

## **Second Street Quarry Club Corporation Ground Rules**

*Revised 12-5-2021*

1. No littering
2. No swimming
3. No one is permitted on the property of the Corporation unless accompanied by a member.
4. No alcoholic beverages are allowed on Quarry property
5. Only two guests per household membership, are permitted on Quarry property
6. Anyone under the age of 10 must wear a Coast Guard Approved personal floatation device (PFD, life jacket) within 10 feet of the water at all times. Some jackets are available in the storage shed on Club grounds, and can be borrowed by members or guests while on Club grounds.
7. Fires must remain in the designated fire ring and controlled at all times. Fires and coals must be completely extinguished before you leave the Club grounds.
8. Grills must be cleaned when finished with use for the day. Members are responsible to bring charcoal for grill use. Please do not leave behind leftover charcoal on the Quarry property.
9. Trash and recycling must be placed in the appropriately designated containers on Club property.
10. When cleaning trout please dispose of entrails into the Quarry water for other fish to feed on. Do not dispose of fish parts into the trash receptacles.
11. Members or guests with pets are required to maintain and keep them under control at all times. Pet waste must be cleaned up. Owners are responsible to immediately repair any damage caused to the Quarry property by their pets.
12. No open burning.  
Borough Ordinance: Ord.88-3 #103  
Within the Borough limits, no person shall:
  - A) Ignite or feed an open fire in any public or private place outside any building.
  - B) Cause, suffer, allow or permit the maintenance of any fire on any property under his control outside of any building.  
(Grills are permitted)  
(Fines may be imposed)
13. If you are found in violation of any of the above mentioned ground rules you will receive a certified letter and be suspended for a 12 month period from the date you were caught. If your suspension falls over the time that dues are to be paid and you do not rejoin, your suspension will carry over until it is fulfilled. Second offense - you will receive a certified letter and you will be expelled for life from the club.

## Second Street Quarry Club Corporation Fishing Rules

*Revised 12-5-2021*

1. The removal of live Baitfish from the Quarry and Corporation Property is prohibited. This includes all panfish species such as Green Sunfish, Bluegill, and hybrids.
2. No bow fishing.
3. Fish taken from the Quarry must be of legal size and in season, unless noted by the Corporation. *The Corporation has the right to restrict the removal of fish by species and size as they feel needed for the betterment of the Corporation.*
4. No stocking of any type fish from waterways to the Quarry by individuals. *Introducing fish from other waterways could introduce parasites, spores, etc., and eradicate our fish in the Quarry.*
5. Do not string fish through the gills unless you plan to keep the fish.
6. The Corporation suggests the use of barbless hooks so that fish are returned to the water with a better chance of survival.
7. Anyone 16 years of age or older must have a valid Pennsylvania fishing license to fish in the Quarry. All members must also have a valid PA trout stamp to harvest trout. **All fish species** removed from the quarry must be recorded on a slip of paper. Please include the date, type, and amount of fish and put the slip in the designated box on Club grounds. This information is used to determine harvest and stocking needs.
8. Trophy trout (18"+) are stocked by donation. If you wish to donate trophy trout please contact the Corporation to arrange payment and details of desired fish type to be stocked.
9. Guests are not permitted to keep any fish from the quarry.
10. Daily creel limits are set per household. All household members may keep fish as long as the sum total of fish kept does not exceed the daily limit per household. Daily limits are posted on the Club bulletin board and Club daily creel limit list annually. To be eligible to keep fish you must be living within the household of General Membership, Lifetime Membership, or Honorary Membership.
11. **NO FISHING of any type within the Club grounds after the first stocking of trout.** Quarry waters will be closed until the opening day and time of Pennsylvania trout season as designated on the annual Club calendar of events.
12. No one is permitted to remove any land or aquatic plants from the Quarry property unless authorized by the board officers for environmental reasons.
13. Odd years will be catch and release only for all species except trout. Even years will be open for species which are specified on the Club's daily creel limit list. Pennsylvania creel limits, sizes, and seasons apply to any species not defined on the Club's daily creel limit list.
14. If you are caught keeping an unspecified or off-limits species, at any time, or found in violation of any of the above mentioned fishing rules, you will receive a certified letter and be suspended for a 12-month period from the date you were caught. If your suspension falls over the time that dues are to be paid and you do not rejoin, your suspension will carry over until it is fulfilled. Second offense - you will receive a certified letter and you will be expelled for life from the Club.

## Second Street Quarry Club Corporation Daily Creel Limits

*Revised 12-5-2021*

Fish harvest is reserved for our Club members only. You must possess a General Membership, Lifetime, or Honorary membership card to harvest fish. Guests are not permitted to harvest any fish from our Club waters.

All odd years are catch and release only for all fish species with the exception of trout. Even years fish may be kept according to the rules stated, by size and quantity as follows:

Trout (all species)	5 daily	7" minimum size
Bass (all species)	Catch and release only	
Crappie (all species)	8 daily	8" minimum size
Yellow Perch	Catch and release only	
Panfish (all species)	6 daily	6" minimum size
Catfish (all species)	5 daily	12" minimum size
Walleye	Catch and release only	
Carp (all species)	Catch and release only	

**Flathead Catfish**                      **Catch and kill, do not return live fish back into the Quarry**

If you are caught keeping an unspecified or off-limits species, at any time, or found in violation of any of the above mentioned daily creel limits, you will receive a certified letter and be suspended for a 12-month period from the date you were caught. If your suspension falls over the time that dues are to be paid and you do not rejoin, your suspension will carry over until it is fulfilled. Second offense - you will receive a certified letter and you will be expelled for life from the Club.

## **Second Street Quarry Club Corporation Boating Rules**

*Revised 12-5-2021*

1. No one under 16 years of age is allowed in a boat unless accompanied by an adult.
2. No boat trailers are to be stored on Club grounds.
3. No one is permitted on water from sunset to sunrise without running lights and an anchor light.
4. Boats shall not be moored or left unattended in the waters of the Quarry at any time.
5. All boats must be kept staged in the Club's boat storage area by the shed when not in use.
6. Boats belonging to members must be removed from the Quarry grounds by November 15 or owning members will be charged \$25 in addition to their annual dues for storage.
7. Only electric motors are permitted. No gas motors, no exceptions.
8. Boats must be registered with the Corporation if members intend to leave their boats on Club property during the fishing season. Member's boat registration numbers will be recorded on the membership list.
9. The Corporation will not be held responsible for any loss or damage to your equipment while on the property of the Corporation.
10. Boats less than 40' in length must carry a device to make a sound audible for a distance of at least one-half mile (whistle). The device must be readily accessible to the operator or passengers of the boat at all times.
11. A Coast Guard Approved wearable Personal Floatation Device (PFD, Life Jacket) is required for each person, on all boats.
12. Children 12 years of age and younger must wear a Coast Guard Approved wearable PFD or life jacket while underway on waters.
13. All persons must wear a Coast Guard Approved PFD or life jacket from the months of November 1st - April 30 while underway, or at anchor on boats less than 16' in length or any canoe or kayak.
14. If you are found in violation of any of the above mentioned boating rules you will receive a certified letter and be suspended for a 12 month period from the date you were caught. If your suspension falls over the time that dues are to be paid and you do not rejoin, your suspension will carry over until it is fulfilled. Second offense - you will receive a certified letter and you will be expelled for life from the club.
